# BELDS MECHANISMS UNDER THE PROJECT

- Conducting a situation analysis with the participation of stakeholders (state structures, experts, NGOs)
- Discussion of the results with a wide range of specialists in preschool education;
- Development of new legal documents;
- Discussion of new legal documents with stakeholders (MON, Department (departments) of education, preschool institutions and local experts.
- Development of new forms of interaction between parents and preschool institutions.

# Completed works

- Coordination of the project implementation plan with the Ministry of Education and Science
- Involvement of a group of external experts for the implementation of the project and conclusion of employment contracts with them
- Holding a meeting with the heads of relevant ministries and departments, institutions of preschool education and international organizations of interest
- Development of methodology and research tools.
- Preparing a group of experts for the study
- Preparation of analytical reports. Preparation of presentations (presentations) on the results of the study

# EXPECTED RESULTS

- Submit to the Ministry of Education and Science for further use a new version of the "Guidelines on regulatory (personal) financing in state preschool educational institutions of the Republic of Tajikistan";
- Submit to the Ministry of Education and Science for further use the Methodological Manual for employees of preschool educational institutions and the work schedule of departments in state preschool educational institutions;
- To the Center for the implementation of PPP projects of the State Committee for Investments and State Property Management, submit the "Manual for the implementation of the PPP mechanism in the field of preschool education."
